### ***Are we being lied to about the covid virus? New research I found From Fierce Biotech***

University of Arizona Professor Floyd (Ski) Chilton, Ph.D., has been studying an enzyme related to rattlesnake venom for 30-plus years. Now, he has evidence that the enzyme could drive severe forms of COVID-19—and provide a new target for reducing mortality from the virus.

Chilton's team worked with researchers at Stony Brook University and Wake Forest University School of Medicine to study blood samples from 281 COVID patients. They discovered that levels of the enzyme secreted phospholipase A2 group IIA (sPLA2-IIA) could predict which patients were likely to succumb to the disease, they reported in the *Journal of Clinical Investigation*.

The enzyme is similar to an enzyme in rattlesnake venom that can bind to receptors in muscles and paralyze them. In people, sPLA2-IIA normally occurs at low levels and is perfectly safe—in fact, it actually protects against infections by destroying the cell membranes of microbes. But in high quantities, it can “shred” vital organs, Chilton explained in a [statement](#).

### ***Snake venom?***

Things can change quickly in medical science, especially during a pandemic.

Rewind to 2018, and Monash University pharmacologist Dr Sanjaya Kuruppu wins a prestigious [grant](#) from the United States to research a peptide from a deadly snake that may prevent Alzheimer's disease.

The team he co-leads gets to work – with new funding from the US government's National Institutes of Health (NIH) – on investigating a molecule from the Bothrops asper, a pit viper from South and Central America.

It is an aggressive snake that accounts for the most snake-bite deaths in the region. But its venom looks like it can counter the toxic protein amyloid beta, which is a cause of Alzheimer's disease; a molecule in the venom perks up two enzymes that clear amyloid beta.

On the team are Dr Kuruppu's mentor, Professor Ian Smith, Monash University's Vice-Provost (Research and Research Infrastructure); Professor Helena Parkington from Monash's Biomedicine Discovery Institute (BDI); and Dr Niwanthi Rajapakse, a senior lecturer at the University of Queensland. Dr Kuruppu works for the Monash Venom Research Laboratory (within BDI) from the University of Queensland.

*Snake venom kills people, so how can it cure someone of covid?*

*Waste water testing by CDC.*

In response to the COVID-19 pandemic, CDC launched the National Wastewater Surveillance System (NWSS) in September 2020. CDC developed NWSS to coordinate and build the nation's capacity to track the presence of SARS-CoV-2, the virus that causes COVID-19, in wastewater samples collected across the country.

CDC's [NWSS works with health departments](#) to track SARS-CoV-2 levels in wastewater so communities can act quickly to prevent the spread of COVID-19. NWSS is transforming independent local efforts into a robust, sustainable national surveillance system.

Wastewater surveillance can provide an early warning of COVID-19's spread in communities.

People infected with SARS-CoV-2 can shed the virus in their feces, even if they don't have symptoms. The virus can then be detected in wastewater, enabling wastewater surveillance to capture presence of SARS-CoV-2 shed by people with and without symptoms. This allows wastewater surveillance to serve as an early warning that COVID-19 is spreading in a community. Once health departments are aware, communities can act quickly to prevent the spread of COVID-19. Data from wastewater testing support public health mitigation strategies by providing additional crucial information about the prevalence of COVID-19 in a community.

INDIANAPOLIS (WISH) — Scientists at the University of Arizona may have discovered the driving mechanism behind COVID-19 deaths.

Those [scientists](#) found an enzyme circulates in the body causing organ failure and inflammation, the two main complications resulting in death.

The enzyme is called a phospholipase. Phospholipase is also found in rattlesnake venom.

“The enzyme has been associated with inflammatory reactions for many years,” [Dr. David Crabb, chief medical officer at Eskenazi Health](#), told News 8. “At controlled levels, it may help orchestrate reactions to clear infectious agents. But when too active, it can be part of how inflammation damages normal tissues.”

That's exactly what scientists say is happening when a person gets infected with the coronavirus.

In a [news release](#), the lead study author, Dr. Floyd Chilton, said “This enzyme is trying to kill the virus, but at a certain point it is released in such high amounts that things head in a really bad direction, destroying the patient’s cells thereby contributing to multiple organ failure and death.”

News 8 also asked Crabb about treatments to curb these side effects. While there are some inflammation blockers available such as dexamethasone, he said, when a case is that severe the mortality rate is still very high.

**More than 100,000 Americans have died of drug overdoses over a year-long period during the Covid-19 pandemic.**

It is the highest yearly death toll from drugs ever recorded in the US.

Data from the Centers for Disease Control and Prevention shows that overdose deaths rose 28.5% in the 12 months ending this past April.

Experts believe that overdoses likely spiked because of the psychological toll of the pandemic and more synthetic opioids like fentanyl in the supply.

Overdoses rose in all but four of 50 US states.

Using data from death certificates, the CDC estimates that 100,306 people between April 2020 and April 2021, compared to 78,056 deaths reported the year prior.

Why do the local governments and hospitals go along with Fauci and this vaccine mandate and control? He went on to say,

In one month, in March of 2020, Tony Fauci told the world masks don't work, they're scientifically worthless, two months later he ordered every American to put on a mask. He didn't give us any scientific studies that made him change his mind, he simply told us, that's the new law, do what you're told.

All of these rights that the Founders of our country died for, sacrificed their properties, their livelihoods, to give us the Bill of Rights, and all of these rights over 20 months have been obliterated, taken from the American people — but not just the American people. This is a global coup d'état against liberal democracies across the planet.

He went on to say,

And the Green Pass is their coup d'état. The Green Pass is how they consolidate their power over your lives. The Green Pass is not a public health measure. It is a tool for totalitarian control of your transportation, your bank account, your movement, every aspect of your life.

And this is not a new idea. This is the same idea they used in Germany in 1937. They issued a pass for people they wanted to control. And when the South African apartheid government wanted to control the black population of South Africa, what was the most important thing they did? They issued a green pass.

I want you to ask all of people and journalists and press who are here today. **If the Green Pass is about public health, why is it not issued by the health ministry? It's being issued by the financial ministry. Do they think that we are stupid?**

**Because this is a way to control your money, Once you have that Green Pass and they have the digital currency, if somebody tells you, Do not leave Milan, and you go on a trip to Bologna, your money won't work in Bologna. If the government tells you not to buy pizza, they can make it so that your money won't buy pizza at a pizza store. They can control every aspect of your life.**

They tell you that we need a Green Pass to make sure everybody gets vaccinated. But they admit it: the vaccine does not prevent transmission, the vaccine does not prevent you from getting the disease, the vaccine doesn't stop the pandemic. So why do we need to get vaccinated if the vaccine doesn't stop transmission?

I'm gonna tell you for two minutes — I'm going to talk about the vaccines. People say I'm against vaccines. I'm not against vaccines. I'm only against bad vaccines.

I'm not going to tell you what Robert Kennedy thinks. I'm going to tell you what Pfizer told the United States FDA.

Pfizer is the company that has an approved vaccine in the United States. And Pfizer was supposed to have a three-year-study, but they cut it to 6 months. And then they gave vaccinations to all of the controls. Why did they do that? Why did they end the study in 6 months? Because they learned that the antibodies disappear in 6 months and the vaccine no longer provides protection. So they had to end it in 6 months. They could not do what they planned (3 years). They took all of their records for that 6 months and they gave them to FDA. The most important table is the table that tells you All Cause Mortality. How many people died in the vaccine group, how many died in the placebo group during that 6-month period. That table is called "s4." You can all look it up.

Here's what the numbers say. There were 22,000 in the vaccine group. Over 6 months, one died from COVID. In the placebo group, the control group, there were 22,000 people, two died from COVID in 6 months. That allowed Pfizer to tell the American public that the vaccine is 100% effective because two is 100% of one.

Most Americans and most Italians when they hear that the vaccine is "100% effective", what they think is that if they take the vaccine, I have 100% of not dying from COVID. That's not what it means. What it means is they have give 22,000 vaccines to protect one person from dying of COVID. That means they better make sure that the vaccine itself does not kill one person even, because if it kills one person then you cancel out the entire benefit.

**Here's the important thing. In the vaccine group, 20 people died over 6 months from all causes — 20 people of the 22,000. In the control group, only 14 people died of 22,000. That means that if you take the vaccine you are 48% more likely to die over the next 6 months than if you don't.**

**These are Pfizer's numbers, not mine. Here's how the people died. In the control group, one person died of a heart attack over the 6 months. In the vaccine group, 5 people died of heart attacks over the 6 months. That means if you get the vaccine, you have a 500% risk of a fatal heart attack within 6 months. It also means that for every one person who is saved from dying of COVID, the vaccine is killing 4 people from heart attacks.**

This is not a good public health policy. Public health is supposed to save lives. But this is about control and controlling our society and controlling our children. And the only reason that people don't understand what I just said and that people still support the vaccine is one reason: the manipulation of fear.

This is simple mathematics. Anybody can look it up. If you look it up you will be more scared of that vaccine than you are of COVID. But the government and the pharmaceutical companies have a method for turning off people's brains so that they can no longer do simple mathematics. That device is fear. Fear stops us from exercising critical thinking. It allows us to believe that if we just do what we're told then that is the only way to save our lives. It's called the Stockholm Syndrome. And the captors, they lock down a whole country for a year, and people become grateful to their captors and think the only way we can leave here alive is if we have absolute obedience.

I'm going to make one more point and that's this. How many people here have heard of Event 201?

If you haven't heard of it, you should go look at it on Youtube. Event 201 was a simulation of a corona virus pandemic that occurred in New York City in October 2019. We now know that COVID was circulating in Wuhan on September 12, 2019, so a month later, there is a simulated corona virus pandemic in New York.

The people who came to that were the big social media companies, the media companies, Johnson & Johnson, the biggest vaccine company, and it was hosted by three people: 1) Bill Gates, 2) George Fu Gao who's the head of the Chinese CDC, and 3) Avril Haines, the deputy director of the CIA.

**Avril Haines is today the top number one spy in the United States, She is the head of Joe Biden's National Security Agency, so she went from Event 201 to becoming the top spy in our country.**

Who knew that the CIA is a public health agency? It came as a surprise to me.

Because the CIA does not do public health. The CIA does coup d'états. Between 1947 and the year 2000, the CIA was engaged in 73 coup d'états, most of them against democracies, one-third of the countries in the world. If you look at Event 201, there was no discussion of public health. Nobody was talking about how do we get Vitamin D to all the people? How do we get people to lose weight? How do we make sure they eat good food? How do we repurpose medicines to treat people? How do we quarantine the sick? How do we preserve Constitutional rights? Not a word was said about public health.

**Instead, what they were talking about is how do we use the pandemic as a pretext to clamp down totalitarian controls and to deconstruct democracy. They spent one-quarter of the day talking about how to make sure nobody's allowed to spread the rumor that the coronavirus pandemic is laboratory-generated.**

This is October 2019! And they talk about how to lock down the population, how to force them to take experimental vaccines, how to make sure that black people don't start resisting. Because in our country, blacks are very suspicious of the medical establishment, and they were deeply concerned about that resistance.

**When I researched my book, what I learned was that this event, Event 201, was not a one-time occurrence. We found 20 separate pandemic simulations beginning in 2000. One thing they had in common — most of them Bill Gates was involved in, Tony Fauci was involved in — but every one of them the CIA was involved in. The CIA wrote the script, high-level CIA officials participated in every one of those pandemic simulations.**

And they involved hundreds of thousands of people. They were conducted secretly. They used frontline workers, they were training police, and hospital systems and utilities in Europe, in Italy, in Germany, in Canada, in Australia, all at the same time, to do a response to a pandemic, but it was not a public health response. It was a response to use the pandemic for something else.

So they practiced again and again and again: How to use the pandemic as a pretext for imposing totalitarian controls and for obliterating liberal democracy across the planet.

One of the experiments that they used, they found, is called the Milgram experiment — it was a CIA experiment in 1967 — and what the CIA found is that if a powerful medical official orders people to do something wrong, something that violates their conscience, that violates their basic values, 67% of people will obey authority over their values. And 67% of the people will be hypnotized by fear into obeying a position of authority, a figure of authority. But 33% of the people will not obey. And you are the 33%.

And our job is to go out from here today and reach out to our brothers and sisters, the people who are still hypnotized, and tell them that we are going to fight for their freedom until they are able to fight for it themselves. We need to reach out when we leave here



today to all of our brothers and sisters, the 67% who are still hypnotized, and we have to tell them that you need to love your freedom more than you are scared of a germ.

This year we saw the destruction of the American Constitution. That Constitution was written by a group of people who understood that there are worse things than dying. And they put their lives on the front line, their property, their careers, their livelihoods, to fight for freedom, and to fight for those rights that we have lost in the previous 20 months.

And now it's our job now, it is the job of everybody in this crowd, to go out and fight back, to resist, resist, resist, resist, and to reclaim our government, to reclaim our lives, to reclaim our liberty, for our children, for our country, and for all future generations.

And I can tell you this. I will stand side by side with you, and if I have to die for this, I'm going to die with my boots on.

It is hard to get good, honest data out of hospitals nowadays for some reason. I have no clue as to why that is. You'd think things would be more transparent.

Freedom of Information Act requests are rarely speedy, but when a group of scientists asked the federal government to share the data it relied upon in licensing Pfizer's COVID-19 vaccine, the response went beyond typical bureaucratic foot-dragging.

As in 55 years beyond.

That's how long the Food & Drug Administration in court papers this week proposes it should be given to review and release the trove of vaccine-related documents responsive to the request. If a federal judge in Texas agrees, plaintiffs Public Health and Medical Professionals for Transparency can expect to see the full record in 2076.

The 1967 FOIA law requires federal agencies to respond to information requests within 20 business days. However, the time it takes to actually get the documents "will vary depending on the complexity of the request and any backlog of requests already pending at the agency," according to the government's central [FOIA website](#).

Justice Department lawyers representing the FDA note in court papers that the plaintiffs are seeking a huge amount of vaccine-related material – about 329,000 pages.

The plaintiffs, a group of more than 30 professors and scientists from universities including Yale, Harvard, UCLA and Brown, [filed suit](#) in September in U.S. District Court for the Northern District of Texas, seeking expedited access to the records. They say that releasing the information could help reassure vaccine skeptics that the shot is indeed "safe and effective and, thus, increase confidence in the Pfizer vaccine."

But the FDA can't simply turn the documents over wholesale. The records must be reviewed to redact "confidential business and trade secret information of Pfizer or

BioNTech and personal privacy information of patients who participated in clinical trials,” wrote DOJ lawyers in a joint status report filed Monday.

The FDA proposes releasing 500 pages per month on a rolling basis, noting that the branch that would handle the review has only 10 employees and is currently processing about 400 other FOIA requests.

“By processing and making interim responses based on 500-page increments, FDA will be able to provide more pages to more requesters, thus avoiding a system where a few large requests monopolize finite processing resources and where fewer requesters’ requests are being fulfilled,” DOJ lawyers wrote, pointing to other court decisions where the 500-page-per-month schedule was upheld.

Civil division trial lawyer Courtney Enlow referred my request for further comment to the DOJ public affairs office, which did not respond.

Plaintiffs' lawyers argue that their request should be top priority, and that the FDA should release all the material no later than March 3, 2022.

“This 108-day period is the same amount of time it took the FDA to review the responsive documents for the far more intricate task of licensing Pfizer’s COVID-19 vaccine,” wrote Aaron Siri of Siri & Glimstad in New York and John Howie of Howie Law in Dallas in court papers.

“The entire purpose of the FOIA is to assure government transparency,” they continued. “It is difficult to imagine a greater need for transparency than immediate disclosure of the documents relied upon by the FDA to license a product that is now being mandated to over 100 million Americans under penalty of losing their careers, their income, their military service status, and far worse.”

They also argue that Title 21, subchapter F of the FDA’s own regulations stipulates that the agency “is to make ‘immediately available’ all documents underlying licensure of a vaccine.”

Given the intense public interest in the vaccine, the plaintiffs' lawyers say that the FDA “should have been preparing to release (the data) simultaneously with the licensure. Instead, it has done the opposite.”

Siri declined comment.

To meet the plaintiffs’ proposed FOIA deadline, the FDA would have to process a daunting 80,000 pages a month. But the plaintiffs note that the FDA has 18,000 employees and a budget of \$6 billion and “has itself said that there is nothing more important than the licensure of this vaccine and being transparent about this vaccine.”

To be sure, most people -- including many who sanctimoniously proclaim “I do my own research” -- lack the expertise to evaluate the information.

But the plaintiffs, who also include overseas professors from the UK, Germany, Denmark, Australia and Canada, appear to be well-positioned to do so.

As Siri and Howe argue, “Reviewing this information will settle the ongoing public debate regarding the adequacy of the FDA’s review process.”

U.S. District Judge Mark Pittman has set a scheduling conference for December 14 in Fort Worth to consider the timeline for processing the documents.

Since 2017, Xi has in many of the country's critical foreign policy addresses declared that the world is in the midst of "great changes unseen in a century" [百年未有之大变局]. If Li's line marks the highpoint of China's humiliation, then Xi's marks an occasion for its rejuvenation. If Li's evokes tragedy, then Xi's evokes opportunity. But both capture something essential: the idea that world order is once again at stake because of unprecedented geopolitical and technological shifts, and that this requires strategic adjustment.

For Xi, the origin of these shifts is China's growing power and what it saw as the West's apparent self-destruction. On June 23, 2016, the United Kingdom voted to leave the European Union. Then, a little more than three months later, a populist surge catapulted Donald Trump into office as president of the United States. From China's perspective—which is highly sensitive to changes in its perceptions of American power and threat—these two events were shocking. Beijing believed that the world's most powerful democracies were withdrawing from the international order they had helped erect abroad and were struggling to govern themselves at home. The West's subsequent response to the coronavirus pandemic in 2020, and then the storming of the US Capitol by extremists in 2021, reinforced a sense that "time and momentum are on our side," as Xi Jinping put it shortly after those events.<sup>3</sup> China's leadership and foreign policy elite declared that a "period of historical opportunity" [历史机遇期] had emerged to expand the country's strategic focus from Asia to the wider globe and its governance systems.

China's military buildup and its push to develop nuclear-capable missiles is unnerving Congress and U.S. defense officials alike.

"We're witnessing one of the largest shifts in global geo-strategic power the world has witnessed," Joint Chiefs of Staff Chairman Gen. Mark Milley said Wednesday when speaking about China's recent military advances.

PRESIDENT XI JINPING declared in July that those who get in the way of China's ascent will have their "heads bashed bloody against a Great Wall of steel." The People's Liberation Army Navy is churning out ships at a rate not seen since World War II, as Beijing issues threats against Taiwan and other neighbors. Top Pentagon officials have

warned that China could start a military conflict in the Taiwan Strait or other geopolitical hot spots sometime this decade.

Analysts and officials in Washington are fretting over worsening tensions between the United States and China and the risks to the world of two superpowers once again clashing rather than cooperating. President Joe Biden has said that America “is not seeking a new cold war.” But that is the wrong way to look at U.S.-China relations. A cold war with Beijing is already under way. The right question, instead, is whether America can deter China from initiating a hot one.

### **From the Department of Defense report to Congress 2021,**

The Department of Defense (DoD) annual report to Congress on military and security developments involving the People’s Republic of China (PRC) provides a baseline assessment of the Department’s pacing challenge.

It goes on to say,

The PRC’s national strategy to achieve “the great rejuvenation of the Chinese nation” by 2049 is deeply integrated with its ambitions to strengthen the PLA. In 2017, General Secretary Xi Jinping laid out two PLA modernization goals during his speech to the 19th Party Congress: to “basically complete” PLA modernization by 2035 and to transform the PLA into a “world class” military by 2049.

CCP leaders believe that the PRC’s global activities, including the PLA’s growing global presence, are necessary to create an international environment conducive to the PRC’s “national rejuvenation.”

The CCP has tasked the PLA to develop the capability to project power outside China’s borders and immediate periphery to secure the PRC’s growing overseas interests and advance its foreign policy goals.

digital influence capabilities by incorporating advancements in artificial intelligence (AI) to improve the quality and deniability of its messaging.

## **Ties with Russia**

Throughout the COVID-19 pandemic, Russia and the PRC maintained frequent high-level communication and stressed close strategic cooperation on global security and health issues. For the third year in a row, the PLA participated in a Russian strategic command and staff exercise, KAVKAZ-2020, held in the Russian Southern Military District. The PRC and Russia likely perceive further cooperation between the two militaries, including joint defense technology development, exercises, and other military modernization initiatives, as advantageous to their respective interests. Despite continued military cooperation, the PRC and Russia have denied any intent to enter into a formal alliance, apparently viewing the strategic effects of their current cooperation (such as joint bomber patrols) as sufficient to accomplish their goals.

## **From Fox News, China expanding it's power.**

China appears to be eyeing its first permanent military base on the shores of Africa's Atlantic coast, and Washington – not keen on the idea – has already started a diplomatic effort to put the kibosh on any plans, a report said.

U.S. officials, citing classified American intelligence reports, told the Wall Street Journal that Beijing could be eyeing Equatorial Guinea's port city of Bata for the base. The report said Bata already comes with a deep-water port that had been upgraded by China Road & Bridge Co. from 2009 to 2014. The report said U.S. intelligence first learned of the possibility of the base in 2019.

## **China appears to be preparing for a war, from The U.S. Sun on December 6,**

**CHINA has been secretly developing Trojan Horse-style missiles hidden in shipping containers that can be unleashed on enemy ports, experts warn.**

Military analysts believe the country's huge fleet of freighters and fishing vessels could be turned into warships with the use of the secretive container missiles.

Disguised as a regular shipping containers, they can be sneaked on board a vessel to blend in seamlessly with the hundreds of others on board.

The sheer number of container ships in the world makes them harder to pinpoint than warships in the event of war.

Like the fabled Trojan Horse, the missiles would be quietly smuggled into or near an enemy port on a civilian vessel before being unleashed in a surprise attack.

Rick Fisher, senior fellow in Asian military affairs at the International Assessment and Strategy Center, told The Sun Online while Chinese have not officially confirmed they have the missiles - it is likely they have them.

And it was warned in a study by [Stockton Center for International Law](#) that the weapons could violate naval laws.

Meanwhile, retired Navy Capt. Jim Fanell, a former Pacific Fleet intelligence chief, previously said a containerized anti-ship missile would add a significant threat to the US Navy.

It comes amid a new wave of tensions between the US and China as the Communist giant challenges Washington's status as the world's top superpower.

### **China is expanding its space program to outdo the U.S. and has made strides which is putting us behind. From Space.com**

China became the third country ever to launch a human into space in 2003 and has been expanding its space program ever since.

The details of the arrangement were kept secret from the laity. Three years later, however, the repression of Christians, whatever their denomination, is at its highest point since the Cultural Revolution. As the Chinese Communist Party celebrates its centenary, Christianity—and other faiths—remain among the challengers it fears most.

Religious controls have been part of communist practice since the foundation of the People's Republic of China. As a result, churches split into "patriotic" associations, officially sanctioned if frowned upon. Unrecognized denominations' status ranged, depending on the government's mood, from fully underground to operating openly but cautiously.

Recent restrictions on Christian practices began to intensify in 2018, the same year the accord with the Vatican was signed. Since then, many churches have been shut down—mostly unsanctioned ones but including some officially recognized groups. Between 5,000 and 10,000 Christian churchgoers have been arrested, some prominent Protestant clergy have been given long prison sentences, and around two-thirds of China's Protestants have resorted to underground churches in an attempt to avoid police harassment.

Government officials have been asked to compile more details of worshippers, feeding into discrimination in employment, especially in official posts. All children under age 18 have been strictly prohibited from attending any kind of religious education—theoretically already the case but not strongly enforced beforehand. Religious leaders are now expected to spend more time extolling the CCP and Chinese President Xi Jinping personally than they do seeing to their flock. In some churches, icons of Jesus or Mary



have already been replaced with portraits of Xi. The old State Administration for Religious Affairs has been abolished and the handling of faith instead moved under the auspices of the United Front—a group that coordinates efforts to coerce all forms of civil society for the party's ends.

The data also show that 111 COVID-19 patients are hospitalized in serious condition in hospitals across the country, of whom 64 are connected to respirators. About 81.5% of patients in serious condition are not vaccinated at all.

Pfizer is working toward a vaccine that protects people against all variants of the virus that causes COVID-19, but meanwhile, the pharmaceutical giant is planning to submit data to the Food and Drug Administration for a fourth dose of its current vaccine, according to CEO Albert Bourla.

"It's clear that there is a need in an environment of omicron to boost the immune response," Bourla told [CNBC's "Squawk Box"](#) Friday, adding that his company will submit a "significant progress of data" to the FDA concerning the fourth dose.

The CDC assures Americans that the mRNA and the spike protein it produces in COVID-19 vaccines to create an immune response "don't last long in the body." [On its website](#), the agency states: "Our cells break down mRNA and get rid of it within a few days after vaccination. Scientists estimate that the spike protein, like other proteins our bodies create, may stay in the body up to a few weeks."

Further, the CDC says on a web page titled "Myths and Facts about COVID-19 Vaccines" that the "genetic material delivered by mRNA vaccines never enters the nucleus of your cells."

However, the researchers at Lund University in Malmö, Sweden, found that the mRNA vaccine enters human liver cells and triggers the cell's DNA in the nucleus to increase the production of the LINE-1 gene expression to make mRNA.

The whole process occurred rapidly, within six hours, concluded the study, which was published by the university's Department of Clinical Sciences.

Pfizer did not comment on the study's findings, the Epoch Times reported, stating only that its mRNA vaccine does not alter the human genome.

“Our COVID-19 vaccine does not alter the DNA sequence of a human cell,” a Pfizer spokesperson told paper in an email. “It only presents the body with the instructions to build immunity.”

\*\*\*\*Earlier this month, as [WND reported](#), a [peer-reviewed study published in the prestigious journal Cell by researchers at Stanford University](#) found that the spike protein created by the COVID vaccines remains in the body much longer than believed and at levels higher than those of severely ill COVID-19 patients.

The Stanford researchers tested the duration of the protein in the body for 60 days and found that it lasted at least that long.

Dr. Robert Malone, the key inventor of the mRNA technology platform that later was used in the Pfizer-BioNTech and Moderna vaccines, described the implications of the Stanford study as a potential “health public policy nightmare” [in an analysis on his Substack page](#).

The Swedish researchers also concluded the spike proteins expressed on the surface of the liver cells through the vaccine could target the immune system and possibly cause **autoimmune hepatitis**. They noted “case reports on individuals who developed autoimmune hepatitis” after getting the Pfizer shot.

The authors of the study cited the case of a healthy 35-year-old female who developed autoimmune hepatitis a week after her first dose of the Pfizer COVID-19 vaccine. The

researchers said there is a possibility that “spike-directed antibodies induced by vaccination may also trigger autoimmune conditions in predisposed individuals.”
